 - 2.1 If you install D-View 8 on Windows OS, please execute "D-View 8_2.0.5.88_Installation.exe" file and follow the step-by-step procedures in the user manual.
 - 2.2 If you install D-View 8 on Linux OS, such as Ubuntu or Debian, please execute "D-View8_2.0.5.88_Installation.deb" file and follow the step-by-step procedure in the user manual.
- 3 D-View 8 Remote Probe 2.0.5.88 Installation or Upgrade:
 - 3.1 For users who install remote probe for the first time.
 - Please download probe installation software from D-View Web site and execute that installation file.
 - 3.2 For users who already install 1.0.x.x remote probe
 - Please download the probe 2.0.5.88 installation software from the D-View Web site and **upgrade it manually**.
 - 3.3 For users who already install 2.0.x.x remote probe
 - If the connection between the remote probe and the core server is maintained, upgrading from v2.0.x.x to v2.0.5.88 during the installation process will also upgrade the remote probe to v2.0.5.88.
