FAQ

How do I restore my Extender SE30 to its factory default?

Locate the reset button on the right side of SE30. With your SE30 powered on, use an unfolded paper clip to press and hold the button for 10 seconds. The SE30 will then reboot and restore its factory default settings.

What do I do if I have forgotten the account name or password for my SE30's web-based configuration utility?

If you forgot the device account or password of your SE30's web-based configuration utility, you must reset your Extender SE30. This process will change all your SE30's settings back to its factory default.

Why can't I access the Internet after setting up my Extender SE30?

The Wi-Fi signal to your Extender SE30 may be weak (Solid Red) if the device is placed in a location where it cannot receive a strong signal from the uplink router, or if it has been moved outside the router's Wi-Fi coverage area. Check that your uplink router is operating normally; if not, refer to your wireless router's manual for troubleshooting.

Why can't I access the web-based configuration utility of my Extender SE30?

If this is your first login after setting up your SE30, make sure that your wireless device, such as a PC, laptop, smartphone, or tablet is connected to the SE30's network and you have correctly entered **https://192.168.0.50/** into your browser. You can find your SE30's MAC address, default Wi-Fi Name/SSID, default Wi-Fi Password, and Device Password on the device label on the back of SE30.

Power	Blinking Green	The device is powered on and the system is in the startup process. The LED blinks green at 1-second intervals.

Internet	Solid Green	An active Internet connection is detected by a connectivity test (ping).
	Off	No Ethernet cable is connected to the Internet (WAN) port when operating in Bridge Mode. Note: In Bridge Mode, the Ethernet port functions as the Internet (WAN) port.
2.4G WLAN	Solid Green	A 2.4 GHz extender connection is established. Signal strength is strong.
	Solid Red	A 2.4 GHz extender connection is established. Signal strength is weak.

LIMITED WARRANTY - AUSTRALIA / NEW ZEALAND ONLY

This warranty prevails over the Global Warranty for goods sold within the Commonwealth of Australia and New Zealand. Subject to the terms and conditions set forth herein, D-Link Australia Pty Ltd. ("D-Link") provides this Limited warranty for its product only to the person or entity that originally purchased the product from:

- D-Link or its authorized reseller or distributor and
- Products purchased and delivered within Australia and New Zealand by D-Link

LIMITED WARRANTY

D-Link warrants that the hardware portion of the D-Link products described below will be free from material defects in workmanship and materials from the date of original retail purchase of the product, for the period set forth below ("Warranty Period"), except as otherwise stated herein.

• Hardware One (1) Year

D-Link Product purchased in Australia on or after January 1, 2012: In addition to the Limited Warranty, D-Link Products come with guarantees that cannot be excluded under the Australian Consumer Law. You are entitled to a replacement or refund for a major failure and compensation for any other reasonably foreseeable loss or damage. You are entitled to have the goods repaired or replaced if the goods fail to be of acceptable quality and the failure does not amount to a major failure. Full details of your consumer rights may be found at www.consumerlaw.gov.au.

D-Link's sole obligation shall be to repair or replace the defective Hardware during the Warranty Period at no charge to the original owner or to refund at D-Link's sole discretion. Such repair or replacement will be rendered by D-Link at an Authorized D-Link Service Office. The replacement Hardware need not be new or have an identical make, model or part. D-Link may in its sole discretion replace the defective Hardware (or any part thereof) with any reconditioned product that D-Link reasonably determines is substantially equivalent (or superior) in all material respects to the defective Hardware. Repaired or replacement Hardware will be warranted for the remainder of the original Warranty Period from the date of original retail purchase. If a material defect is incapable of correction, or if D-Link determines in its sole discretion that it is not practical to repair or replace the defective Hardware, the price paid by the original purchaser for the defective Hardware will be refunded by D-Link upon return to D-Link of the defective Hardware. All Hardware (or part thereof) that is replaced by D-Link, or for which the purchase price is refunded, shall become the property of D-Link upon replacement or refund.

LIMITED SOFTWARE WARRANTY

D-Link warrants that the software portion of the product ("Software") will substantially conform to D-Link's then current functional specifications for the Software, as set forth in the applicable documentation, from the date of original retail purchase of the Software for a period of ninety (90) days ("Warranty Period"), provided that the Software is properly installed on approved hardware and operated as contemplated in its documentation. D-Link further warrants that, during the Warranty Period, the magnetic media on which D-Link delivers the Software will be free of physical defects. D-Link's sole obligation shall be to replace the non-conforming Software (or defective media) with software that substantially conforms to D-Link's functional specifications for the Software or to refund at D-Link's sole discretion. Except as otherwise agreed by D-Link in writing, the replacement Software is provided only to the original licensee, and is subject to the terms and conditions of the license granted by D-Link for the Software. Software will be warranted for the remainder of the original Warranty Period from the date of original retail purchase. If a material non-conformance is incapable of correction, or if D-Link determines in its sole discretion that it is not practical to replace the non-conforming Software, the price paid by the original licensee for the non-conforming Software will be refunded by D-Link; provided that the non-conforming Software (and all copies thereof) is first returned to D-Link. The license granted respecting any Software for which a refund is given automatically terminates.

NON-APPLICABILITY OF WARRANTY

The Limited Warranty provided hereunder for hardware and software of D-Link's products will not be applied to and does not cover any refurbished product and any product purchased through the inventory clearance or liquidation sale or other sales in which D-Link, the sellers, or the liquidators expressly disclaim their warranty obligation pertaining to the product and in that case, the product is being sold "As-Is" without any warranty whatsoever including, without limitation, the Limited Warranty as described herein, notwithstanding anything stated herein to the contrary.

SUBMITTING A CLAIM

The customer shall return the product to the original purchase point based on its return policy. In case the return policy period has expired and the product is within warranty, the customer shall submit a claim to D-Link as outlined below:

- The customer must submit with the product as part of the claim a written description of the Hardware defect or Software non-conformance in sufficient detail to allow D-Link to confirm the same.
- The original product owner must obtain a Return Material Authorization ("RMA") number from the Authorized D-Link Service Office and, if requested provide written proof of purchase of the product (such as a copy of the dated purchase invoice for the product) before the warranty service is provided.

- After an RMA number is issued, the defective product must be packaged securely in the original or other suitable shipping package to ensure that it will not be damaged in transit, and the RMA number must be prominently marked on the outside of the package. Do not include any manuals or accessories in the shipping package. D-Link will only replace the defective portion of the Product and will not ship back any accessories.

- The customer is responsible for all in-bound shipping charges to D-Link. No Cash on Delivery ("COD") is allowed. Products sent COD will either be rejected by D-Link or become the property of D-Link. Products shall be fully insured by the customer and shipped to **D-Link Australia Pty Ltd., 6 - 10 Talavera Road, North Ryde, NSW 2113**. D-Link will not be held responsible for any packages that are lost in transit to D-Link. The repaired or replaced packages will be shipped to the customer via UPS Ground or any common carrier selected by D-Link, with shipping charges prepaid. Expedited shipping is available if shipping charges are prepaid by the customer and upon request.

D-Link may reject or return any product that is not packaged and shipped in strict compliance with the foregoing requirements, or for which an RMA number is not visible from the outside of the package. The product owner agrees to pay D-Link's reasonable handling and return shipping charges for any product that is not packaged and shipped in accordance with the foregoing requirements, or that is determined by D-Link not to be defective or non-conforming.

WHAT IS NOT COVERED

This Limited Warranty provided by D-Link does not cover: Products, if in D-Link's judgment, have been subjected to abuse, accident, alteration, modification, tampering, negligence, misuse, faulty installation, lack of reasonable care, repair or service in any way that is not contemplated in the documentation for the product, or if the model or serial number has been altered, tampered with, defaced or removed; Initial installation, installation and removal of the product for repair, and shipping costs; Operational adjustments covered in the operating manual for the product, and normal maintenance; Damage that occurs in shipment, due to act of God, failures due to power surge, and cosmetic damage; Any hardware, software, firmware or other products or services provided by anyone other than D-Link; Products that have been purchased from inventory clearance or liquidation sales or other sales in which D-Link, the sellers, or the liquidators expressly disclaim their warranty obligation pertaining to the product. Repair by anyone other than D-Link or an Authorized D-Link Service Office will void this Warranty.
